Significance of Accepting Admission to Rider University

By the act of accepting admission to Rider University, students acknowledge and agree to the following:

1. that they will be bound by and comply with all University standards and policies, including but not limited to, those standards and policies set forth in this catalog and in the student handbook (The Source (<http://www.rider.edu/offices-services/handbooks-policies/theseource>)). **Primary and ultimate responsibility for knowing and conforming to these standards and policies and degree requirements resides with the individual student.**
2. that the ultimate authority to regulate and maintain order on the University campuses resides with the President and the Board of Trustees; and,
3. that the University retains ownership and the exclusive right to use any and all promotional, publicity, and entertainment products (including those produced as course requirements), creations, and activities engaged in by the student while at the University, including but not limited to photographs, television, audio and video recordings, motion pictures, artistic performances and presentations, internet/web-based productions and sales, and athletic events and all proceeds therefrom.
